2.0 Percent Benefit Increase for 2018

Monthly Social Security and Supplemental Security Income (SSI) benefits for more than 66 million Americans will increase 2.0 percent in 2018, the Social Security Administration announced today.

The 2.0 percent cost-of-living adjustment (COLA) will begin with benefits payable to more than 61 million Social Security beneficiaries in January 2018. Increased payments to more than 8 million SSI beneficiaries will begin on December 29, 2017. (Note: some people receive both Social Security and SSI benefits) The Social Security Act ties the annual COLA to the increase in the Consumer Price Index as determined by the Department of Labor's Bureau of Labor Statistics.

Some other adjustments that take effect in January of each year are based on the increase in average wages. Based on that increase, the maximum amount of earnings subject to the Social Security tax (taxable maximum) will increase to \$128,700 from \$127,200. Of the estimated 175 million workers who will pay Social Security taxes in 2018, about 12 million will pay more because of the increase in the taxable maximum.

Request for Information on Potential Stay-at-Work/Return-to-Work Demonstration Projects

Social Security and the Department of Labor's Office of Disability Employment Policy are [seeking public input](#) for Information on Potential Stay-at-Work/Return-to-Work Demonstration Projects. Through this research, we hope to identify effective strategies for supporting workers who want and are able to keep working while living with a disability.

Specifically, we are asking for recommendations on the early intervention strategies to be tested (to promote labor force attachment, coordinate employment and health services, and support injured and ill workers in returning to and remaining at work) and on the design of a potential demonstration.

This notice builds on Social Security's "Request for Information on Strategies for Improving Work Outcomes for Individuals with Musculoskeletal Disabilities" last year, for which many of you submitted comments. We appreciate your input and encourage all interested parties to respond to the current notice.

Revised Form I-765, Application for Employment Authorization

Stakeholder Engagement

Wednesday, Oct. 18, 2017 from 2 to 3 p.m. (Eastern)

U.S. Citizenship and Immigration Services (USCIS) and the Social Security Administration (SSA) invite you to participate in a stakeholder teleconference on **Wednesday, Oct. 18, from 2 to 3 p.m. (Eastern)**, to discuss the revised USCIS [Form I-765, Application for Employment Authorization](#). As of Oct. 2, 2017, Form I-765 applicants will have the option to apply for a Social Security number (SSN) at the same time they apply for employment authorization or for an Employment Authorization Document (EAD). SSA estimates this will reduce visits to their offices by almost 400,000 annually.

During this session, representatives from USCIS and SSA will review the updates made to the form, provide an overview of the process of obtaining a SSN, and answer your questions.
